- 5. Committee Reports
  - a) Roads Committee Ron Morris estimated that \$8,500 in road fees have been collected in the last four years. Those funds are available to spend on road repairs. Members have donated \$1,200 toward road repairs.
  - b) ACC Committee Jack Hammons reported that some members are making improvements and one member is pouring a slab.
  - c) Fundraising Committee Pat Simmons reported the bank balance was \$2,073.91 on December 31, 2019. The committee has approved the purchase of a PA system for the clubhouse. The estimated cost will be \$500.
  - d) Bass Club Ron Morris reported there are 12 members signed up. The first tournament is scheduled at Lake Fork on February 29<sup>th</sup>.
