### Notes from the President

**Board Meeting Synopsis** 

The Board Meeting was held on May 11th at 10:00 AM.

For you members that were not present at this meeting, an envelope was handed to the President to be opened and read at the meeting. After the preliminary openings, the letter was read aloud. The letter was several pages long and submitted by Wanda Hammons. You can obtain a copy of this letter from the Park Office if you would like to read it.

As, I am sure you have noticed, the road repairs have been done. The Top Coat for the roads was not done. The monies to do this procedure were not in the Budget for this year.

The Errors & Omission Insurance Claim Letter has been sent to our insurance carrier and they have sent it on to the Underwriters that carry our insurance. We received confirmation of receipt from the underwriters.

There have been no new corrections or references to any omissions in the rewrites of the Deed Restrictions or the By-Laws. These rewrites will be sent to the proof readers this week. The financial parts were removed from the Deed Restriction and put into the By-Laws since the By-Laws are the rules and regulations that control the Business part of our Park and the Deed Restrictions take care of the maintenance and beautification side of the Park. Of course this means that we can't pass the Deed Restrictions without passing the By-Laws.

This also means that both of them

must be accepted or rejected on the same Annual ballot vote this Fall. This should clear up the problem of having the By-Laws and the Deed Restrictions agree. These both will be in step with the Title 11 Texas Property Code, Chapter 209. If these are not approved, then we stay with the 2009 recorded Deed Restrictions. But we will still not be in compliance with Chapter 209. So some of our Deed Restrictions and By-Laws are still not legal any more.

We did not replace the vacant Board position since this was so close to the end of the year.

The Board is including a letter in your quarterly dues and assessments asking all the member if they would like to receive their bills electronically. If you want to receive them by email instead of by regular mail, please send an email or call the office so that Tammy knows if you want them set by email, This will begin for the October, November, December billing.

We have a new webmaster. He is Woody Harper. Woody has an extensive background in computers and networking. Thank you, Woody, for volunteering to do this for the Park. Woody and I will get together to bring the website current during the summer months. According to Texas laws we have to have certain documents posted on our website.

We did not have any complaints this month.

Our next Board Meeting is tentatively scheduled for August 24th or sooner. At this meeting we will be starting to list the documents for the Annual Meeting packets.

#### NEVER BUY JEWELLERY CLEANER AGAIN!

- 1 tablespoon salt
- 1 tablespoon baking soda
- 1 tablespoon dish detergent
- 1 cup water

- 1. Heat water in the microwave for 1 or 2 minutes.
- 2. Cut a piece of aluminum foil that roughly covers the bottom of a small bowl (like a cereal bowl).
- 3. Pour hot water into bowl. Place salt, soda, and dishwashing liquid into bowl. Place jewelry on top of foil and let it sit for 5 to 10 minutes. Rinse jewelry in cool water and dry jewelry completely with soft cloth. Discard solution after use and make a new batch next time

#### DEED RESTRICTIONS EXCERPTS


