- 4. Treasurer's report Pat Simmons reported \$13,981.00 is available for discretionary use after deducting \$20,000 for the reserve from the \$33,981.00 balance as of November 11, 2022. • Office repair and upgrades – Lois Compton reported the repairs and upgrades that are needed on the office. The Association will pay to repair the roof.

## Committee Reports:

- Fundraising Pat Simmons reported a bank account balance of \$3,000.94 with \$602.03 for office repairs and upgrades and \$2,398.91 for use by the committee. Thanksgiving dinner will be November 11<sup>th</sup> and the Christmas Party will be December 10<sup>th</sup>.
- ACC Dan Wax reported that Mike Reitz is the Committee Chair and Herman Ansley is the Committee Co-Chair. Other members are Dan Wax, Steve Greene, Randy Harper, Charlie Baker, and Larry Compton.
- Roads Ron Morris reported that five members are still paying out the road assessment. Ground asphalt has been placed in the potholes, but it is dry.

#### **New Business**

- 1. Mailboxes Jim Langley reported that there is one mailbox available. Another cluster mailbox will be added when there are five or more members on the waiting list.
- 2. Projects Jim Langley reported the following for the bath houses: toilet flanges, paint the floors, heater for the ladies' room, new heater for the men's room, fix the attic fans, paint interior and exterior walls, and repair termite damage. Additional items are: Outdoor lighting is needed for the clubhouse and pavilion. The fence around the pool needs repairs. Front fence needs painting or staining. Replace sign in front of the office.
